Note: Artisan Partners Limited Partnership (or "APLP") is controlled by its general partner, Artisan Investments GP LLC. The sole member of Artisan Investments GP LLC is Artisan Partners Holdings LP. Artisan Partners Holdings LP (or "APH") is controlled by its general partner Artisan Partner Asset Management Inc. (or "APAM").

Each employee of APAM to whom equity has been granted is party to a stockholders agreement ("Stockholders Agreement") pursuant to which such persons granted an irrevocable voting proxy with respect to all shares of APAM's common stock acquired from APAM, and any shares that may be acquired from APAM in the future, to a stockholders committee. Collectively, the stockholders subject to the Stockholders Agreement currently control approximately 69% of the voting stock of APAM. Shares of APAM's common stock subject to the Stockholders Agreement will be voted in accordance with the majority decision of the three members of the stockholders committee. Therefore, the Committee will effectively control APAM and, indirectly, APH and APLP. Currently the stockholders committee consists of Mr. Colson (President, Chief Executive Officer and a Director of APAM), Mr. Daley (Executive Vice President, Chief Financial Officer and Treasurer of APAM) and Mr. Ramirez (Senior Vice President of APAM).
